## Being a by-law to authorize the stopping up, closure and sale of part of Old Lakeshore Road, Dunnville

- 7. **THAT** the Mayor and Clerk are hereby authorized to execute the necessary documents required to give effect to the intention herein.
- 8. AND THAT this by-law shall take force and effect on the date of passing.
