This letter is to inform you that we have received an Addition to Reserve proposal from the Mississauga's of the Credit First Nation. The details are as follows:

- 1) 4136 Highway #6 ATR Property: The proposed land for the highway area compromises approximately 124.643 hectares (308.0 acres) consisting of 4 parcels located within the Haldimand County:

This proposal is for fee simple patent land acquired pursuant to the Toronto Purchase Settlement Agreement dated November 1996, between the Mississauga's of the Credit First Nation and Canada.

These proposals are subject to the requirements of Canada's Additions to Reserve/Reserve Creation Policy (2016). The policy can be found on the ISC website at







At this time we encourage the Haldimand County to review the proposal and provide the Mississauga's First Nation and ISC Regional Office with a written response to the proposal which may outline your support and any concerns your respective Government may have. Please provide this response by August 25, 2025. Your input will be considered by the Department as part of our review of the proposal.

While local governments do not have a general or unilateral veto regarding reserve creation proposals, Canada encourages the Haldimand County to work collaboratively with the Mississauga's of the Credit First Nation to resolve issues of concern and mutual interest. As part of the reserve creation process, the County and the First Nation may address issues or negotiate agreements such as, but necessarily limited to, services, by-law harmonization, joint land use planning, fire protection, consultation and dispute resolution processes for matters of mutual concern, or potential net tax loss adjustments. Organizations such as the Federation of Canadian Municipalities and the National Aboriginal Land Managers Association are available to offer support to both your Government and the First Nation during this process. While Canada is not a party to any agreements between the County and the First Nation, where requested, Canada may provide facilitative or technical assistance in support of any discussions.
