#### F. Items for Consideration

1. Member Resignation Letter

Staff signed a letter to Marianne Kidd thanking her for her time as a member of the Accessibility Advisory Committee.

2. Selkirk Waterway Development

Members reviewed drawings of the proposed Selkirk Waterway Development Project. They had the following questions that will require follow-up:

- Does the walkway go as far as the bridge to hook up with the paved trail?
- Could we add another accessible parking space so more than one accessible vehicle can go there at a time?
- Can we make sure the picnic table is an accessible one?
- Could we look into getting rubberized interlocking brick in the parking lot like the area along Highway 3?
- Can we look into getting an accessible portable washroom?
- 3. Port Maitland Boat Ramp Reconstruction

Members reviewed drawings of the Haldimand County Port Maitland Pier Dock Repair Project

Concern: Accessible spots are not deep enough by the playground

Other concerns related to congestion in the summer and the desire for more bylaw

4. GIS Mapping - Accessibility items

Members were not aware GIS maps were available to the public and have asked for GIS to show them more at the next meeting. Suggestions were made to add emergency locations/stations as well as accessible trails and buildings as a layer to the map. 5. Access-Ability Week Ideas

Staff discussed Access-Ability Week Ideas (Access-Ability week is at the end of May)

- Members want an event that includes the community, potentially educational
- Highlight companies like "True Experience" that hire individuals with disabilities
- Share the GIS map (with accessibility related layers) with community

- Accessibility award for individuals/groups/business's furthering accessibility in the community
