THE CORPORATION OF HALDIMAND COUNTY

By-law Number /18

Being a by-law to assume the road widening on Dickhout Road, Dunnville, and to establish these lands as an open public highway to form part of Dickhout Road

WHEREAS The Corporation of Haldimand County has passed By-law No. 1515/15 on March 9, 2015 to delegate authority to the Director of Engineering and the Manager of Support Services to jointly deal with acquiring road widenings under certain circumstances:

WHEREAS the requirements of said By-law 1515/15 have met the criteria to accept ownership of an unregistered road widening over Part of Lots 16 and 17, Concession 2 from Lake Erie, Moulton, now Haldimand County, designated as Part 2 on 18R-3268, which is comprised of part of PIN 38125-0120 (LT) (hereinafter described as the "Road Allowance");

WHEREAS the necessary Acknowledgement and Direction to transfer title of the subject Road Allowance to The Corporation of Haldimand County will be registered imminently;

WHEREAS Section 31 of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended provides that a municipality may by by-law assume for public use a road allowance, highway, street or lane;

AND WHEREAS The Council of The Corporation of Haldimand County deems that it is in its best interest to assume the Road Allowance for public use under the *Municipal Act, 2001*, S.O. 2001, as amended.

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

- 1. THAT, upon registration of the necessary transfer of title of the subject lands, the Road Allowance being Part of Lots 16 and 17, Concession 2 from Lake Erie, Moulton, now Haldimand County, designated as Part 2 on 18R-3268, which is comprised of part of PIN 38125-0120 (LT), be and is hereby assumed for public use under and for the purposes of the *Municipal Act*, 2001, S. O. 2001, as amended.
- 2. THAT the Mayor and Clerk of The Corporation of Haldimand County are hereby authorized and instructed to execute the necessary documents required to give effect to the intention herein, and the Clerk of The Corporation of Haldimand County is hereby authorized to affix the Corporate Seal of The Corporation of Haldimand County to this by-law and to all other related documents as may be required.
- 3. **AND THAT** the Clerk of The Corporation of Haldimand County is hereby instructed to register a copy of this by-law, certified under her hand and the seal of the Municipality, on title to the Road Allowance.
