# HALDIMAND COUNTY

Report PED-COM-07-2018 Major Festival and Events Enhancement 2018 Grants



For Consideration by Council in Committee on March 27, 2018

### **OBJECTIVE:**

To obtain Council's approval for the Major Festival and Event Enhancement Grants for 2018.

#### **RECOMMENDATIONS:**

- 1. THAT Report PED-COM-07-2018 Major Festival and Event Enhancement 2018 Grants be received;

### **EXECUTIVE SUMMARY:**

Council passed a resolution on May 20, 2014 to provide financial support for Major Festivals and Events. The goal of the financial support is to encourage the development of event capacity and/or to increase attendance. Recent event and festival attendance figures indicates that the number of attendees has increased over the past 3 years.

The community volunteers and groups that host the local festivals and events, enhance the quality of life and sense of community for the residents of Haldimand County. Festivals and events also make significant contributions to the local economy and help boost tourism. The Major Festival and Event Enhancement Grant Program (MFEEGP) links to the each of the strategic priorities:

- Growing our Local Economy by Creating Economic Opportunities;
- Community Vibrancy & Healthy Community; and
- Corporate Image and Efficient Government.

All fourteen (14) applicants for a 2018 grant have met the MFEEGP requirements. Staff are recommending for 2018, a total of \$100,000 for fourteen (14) community festivals be approved.

### **BACKGROUND:**

It was recommended in 2014 that the County establish a festival grant program on a 5 year pilot basis for the years (2014 to 2019) inclusive and evaluate the program at the end of this time frame.

In February 2015, Council adopted the Festival and Event Policy (No. 2015-02) and the associated Funding and Administrative Guidelines.

The Major Festival and Event Enhancement Grant Program (MFEEGP) highlights are as follows:

 Financial assistance will only be available to Event Organizers who meet the definition of a Major Festival or Event.

The definition of a Major Festival or Event:

- An organized non-profit event, recurring annually, which incorporates an intensive level
  of planned activity, a multi-faceted program of arts, cultural, sports or entertainment within
  a period of time that provides community benefit;
- Is accessible to and provides broad access and participation to all residents of the County and/or tourists and has significant attendance levels (500+) relative to the size of the festival budget;
- Has an operating budget over \$10,000;
- Has received Council approval;
- Is mostly, if not all, held on County owned property; and
- Will restrict or limit community use of County owned facilities, properties, roads and/or amenities for a day or more.
- An initial annual County operating budget of \$60,000 was established in 2014. In 2016, the policy
  was changed to expand eligibility and resulted in an increase in the number of grant submissions.
  As a result, Council approved \$100,000 of funding per year, starting with the 2016 tax supported
  operating budget.
- The program includes one annual intake for MFEEGP applications, with the intent to complete the review and approval, and to flow the funding within 4 6 weeks of this date.
- To ensure that applications meet the criteria of the program, applications require a festival and event budget submission related to expenditures, revenues and reserves of the organizer that is applying.
- The festival/event and financial information are evaluated according to the program principles and criteria, and a report to Council is required for approval of the grant allocations.
- Organizations that have arrears with the County will not be eligible for the program.
- For ease of administration, the following funding model was implemented:
  - Base amount of \$5,000 for festivals with a total budget of \$50,000 or less; and \$10,000 for festivals with a total budget over \$50,000.

The following changes to the Festival and Event Policy No. 2015-02 were approved by Council:

#### In 2016:

- 1. In recognition of the significant contribution to community vibrancy of traditional Agricultural Fairs in the County and the inability for this scale of activity to be housed on County property, the MFEEGP was updated to provide eligibility for Agricultural Fairs.
- 2. The funding model was updated to provide the flexibility to provide grant funding less than the applicable base amount based on the grant request i.e. if an organization asks for less than the maximum amount.

#### In 2017:

3. Council recognized that the limited space and limited infrastructure available in the Caledonia Kinsmen Park was a barrier to the growth of the annual Caledonia Canada Day event hosted by the Caledonia Regional Chamber of Commerce. In 2017, the event was moved to the Caledonia Fair Grounds which provides the room for growth. Although this is not public land, the event was deemed eligible for future grants at this location.

The total number of event organizations receiving grants has increased from six (6) in 2014 to fourteen (14) applications in 2018.

## **ANALYSIS:**

The Grant Review Committee, comprised of staff from Finance, Economic Development and Tourism and Community Development and Partnerships, reviewed the 2018 MFEEGP applications (details of each included in Attachment 1) via a consistent, fair and equitable process.

As per the terms and conditions of the MFEEGP, the successful applicants will be required to meet the following expectations:

- If a festival or event approved under the MFEEGP does not occur in full (with the exception of rain or major catastrophe), the funds must be returned to the County;
- Grant recipients must acknowledge the support of Haldimand County in all print and publicity material for the festival (i.e. literature, advertising, banners or on-site signs);
- Grant recipients must comply with applicable legislation, municipal by-laws and policies as outlined in the Festival and Event Approval Guidelines; and
- Provide a Certificate of Insurance for the festival or event meeting the County's standards.

All organizations receiving a Major Festival and Event Enhancement Grant will be required to complete a final report form outlining how the grant funds were used, festival attendance, etc. The final report is due within 45 days following the major festival. This report is critical in terms of being able to evaluate the impact of the funding program. Organizations who do not submit a final report form will be ineligible for County funding in subsequent years until the final report form is provided. Final reports have been received from all 2017 Event Organizers requesting a Major Festival and Event Enhancement Grant in 2018. All eligible applicants have been contacted by staff relative to the recommendations in the report.

All fourteen (14) groups are eligible for 2018 funding. Staff are recommending that all fourteen (14) applicants be approved and staff will proactively work with each group to ensure that the necessary financial information is complete prior to releasing payment.

## FINANCIAL/LEGAL IMPLICATIONS:

The 2018 Tax Supported Operating Budget as presented to Council on March 7, 2018 includes \$100,000 to support the MFEEGP, pending ratification on April 3, 2018. The total value of 2018 MFEEGP applications eligible for support is \$100,000.
