He advised that there has been an increase in billable calls for service related to theft, mischief, property crime, drugs, and mental health. Alternatively, there has been a decrease in false alarms and 911 hang ups.

The Detachment's visibility plan regarding focused patrols, encompassing both vehicle and foot patrols, was provided to the Board. It was noted that January 2018 saw a 10% increase in foot patrol hours over the same period in 2017.

#### I. NEW BUSINESS

1 Haldimand County Emergency Services Recognition Awards

As a follow up from the June 28, 2017 Police Services Board meeting, both OPP staff and the Board agree that the Police Services Board recognition awards fit well with the Haldimand County Emergency Services awards night. The event is tentatively scheduled for late June, 2018. Inspector Carter noted that the award categories should be reviewed and updated. The Police Services Board Recognition Policy will be discussed at the March 28, 2018 meeting. Member L. Hewitt will act as the Board representative for event details.

2 Haldimand Norfolk Health Unit Report on Alcohol Use and Harms

Discussion ensued regarding community awareness on the impact of alcohol.

# 3 Paid Duty Assignments for Community Events

It was noted that, in some municipalities, event organizers are responsible for the costs related to paid duty officers at community events, rather than the municipality absorbing these costs. J. Whiting will discuss the options with Haldimand County Community Development and Partnership staff.

# 4 Detachment Visibility Plan Including Foot Patrol

Inspector Carter advised that this plan utilizes analytics to predict and deploy officers. This item will be discussed at the March 28, 2018 meeting.

# 5 Ramsey Drive Stop Sign

The Board was advised that a report was presented at the February 27, 2018 Council in Committee meeting regarding a number of unenforceable stop signs within Haldimand County. Final approval and adoption of the appropriate by-law required to allow enforcement of the stop signs will be considered at the March 5, 2018 Council meeting.

1 Chief Superintendent John Cain's Response to Questions Presented at the October 25, 2017 Meeting

# 2 Speed Awareness Devices

The Board was advised that the County approved the budget to purchase 12 speed awareness signs, 1 mobile trailer and 2 speed spy devices. Haldimand County staff will be working with the OPP to procure the devices, and develop a plan for the deployment and placement of speed spy devices, documenting the reasons for choosing each location. It was requested that speed spy results be available on the website for longer than the current three month timeframe.

# 3 Snow Route Congestion and Parking Tickets in Dunnville

It was noted that a number of parking charges have been laid in Dunnville in an effort to allow snow plows to clear accumulated snow effectively.

# 4 Concerns Re: Community Survey

A concerned citizen reported being contacted to respond to a survey focusing on the local community. It was noted that this could be prospective candidates for the upcoming municipal election reaching out to gauge public opinion.
