By-law Number /18

## Being a by-law to provide for drainage works in Haldimand County within the Carter Municipal Drain

**WHEREAS** Section 78 of the *Drainage Act*, R.S.O 1990, c. D17, as amended, provides for the updating of a drainage works described in the said Act;

**WHEREAS** the Council of the Corporation of Haldimand County has procured a report prepared by Spriet Associates London Limited of London, Ontario;

**WHEREAS** the estimated total cost of the drainage works is \$323,000.00;

**WHEREAS** \$48,022.00 of the amount is to be contributed by the Corporation of Haldimand County;

**WHEREAS** \$170,598.00 is being assessed to the landowners within the drainage area of Haldimand County for the drainage works;

**WHEREAS** \$56,080.00 is being assessed to CP Rail for land within the drainage area of Haldimand County for the drainage works;

**WHEREAS** \$48,300.00 is being assessed to Lands and Roads within the drainage area of the Township of Wainfleet for the drainage works;

**AND WHEREAS** Council is of the opinion that the drainage of the area is desirable,

## NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

- 1. **THAT** the Engineer's Report dated April 16, 2018 is hereby adopted, and the drainage works as therein indicated and set forth are hereby authorized and shall be completed in accordance therewith.
- 2. **THAT** the following attachments extracted from the said Engineer's Report attached hereto and forming a part of this by-law are hereby adopted:
  - I. Schedule C Assessment for Construction
  - II. Schedule D- Assessment for Maintenance
  - III. Schedule of Net Assessment.
- 3. **THAT** a special annual rate sufficient to recover the costs of the drainage work and associated interest costs shall be levied upon the lands and roads as set forth in the attached Schedule C to be collected in the same manner and at the same time as other taxes are collected in each year for (5) five years after the passing of a by-law to levy the final costs.

- 4. **THAT** notwithstanding section 5 of this by-law, all assessments of \$500.00 or less are payable in the first year in which assessment is imposed
- 5. **THAT** Haldimand County shall pay a sum of \$48,300.00 being the amount assessed upon the lands and roads belonging to or controlled by Haldimand County.
- 6. **THAT** this by-law shall come into force and effect upon the third and final reading and may be cited as the "Carter Municipal Drain By-Law, 2018".
